Children's Ark Zombie Run sees great support

The Children's Ark Zombie Run 2K and 5K kicked off the Halloween season on Saturday at the Tiyan baseball field.

With assistance from the Guam Running Club, the runners were split into three divisions, men's 5K, women's 5K, and men and women's 2K. Runners were to compete under their divisions with a hundred zombie volunteers scattered throughout the course. Results from the Guam Runners Club showed 378 runners crossing the finish

line, according to event organizer Madelene Campos.

She also said that despite the rain, the Children's Ark was "very grateful for the support and participation of the community." She also teased the zombie run to return next year with hopes of being recognized as an annual event.

Proceeds from the Zombie Run went toward Sanctuary.

The Children's Ark is a nonprofit organization that began by assisting a boy diagnosed with cancer. It hosted a car wash fundrais-

er for him that raised over \$5,000 and gave enough momentum for the organization to expand to other events like the Zombie Run, according to Campos.
