## Plea deal reveals California drug conspiracy

A plea deal between the federal government and Connie C. Tedtaotao, 50, was unsealed in the District Court of Guam on Thursday.

Tedtaotao faces a maximum sentence of 20 years in prison for conspiracy to possess with intent to distribute methamphetamine and also could face a \$1,000,000

Tedtaotao admitted to participating in a conspiracy to bring methamphetamine from California to Guam between August 2014 and August 2015. California has been identified as a source state by the Drug Enforcement Administration.

A 2018 DEA risk assessment report indicated methamphetamine can be purchased for as low as \$10 a gram in the U.S., including California, and is sent to Guam where it is sold for between \$500 and \$750 per gram.

During this time, several packages of methamphetamine arrived on Guam for Tedtaotao and an unnamed co-conspirator to distribute, the plea agreement states.

Tedtatoao knew the packages contained methamphetamine.

The DEA tested the substance from one package picked up on July 7, 2015, coming from a stateside conspirator and determined it to be 25.7 grams of methamphetamine that was 99.4 percent pure.

Another mailed package that the defendant acknowledged was intended for her but sent to a relative on July 18, 2015, contained 10.13 grams of 94 percent pure methamphetamine.

Sentencing is scheduled for May 30. (Daily Post Staff)

# **Guam gets extension to** comply with REAL ID

The government of Guam has received another extension to comply with the federal requirements to issue driver's licenses that comply with the REAL ID Act of 2015.

The new compliance date is April 10, the U.S. Department of Homeland Security stated in a letter to Gov. Lou Leon Guerrero on Jan. 12. DHS' website previously stated Guam's extension to comply with the law ended Jan. 10.

The post-9/11 law is aimed to ensure those who apply for driver's licenses or other government-issued IDs across the nation have the proper documents that show U.S. citizenship or legal immigration status to stay in the country, the U.S. Department of Homeland Security stated.

The federal government shutdown is part of the reason for Guarn's extension.

Plea deal in drug case unsealed

A 61-year-old man faces a maximum penalty of 20 years imprisonment but could receive substantially less because he has been cooperating with federal authorities since March 2018.

A plea agreement and information were unsealed in the District Court of Guam on Thursday in the case against Ernest Quenga.

Quenga pleaded guilty to conspiracy to possess with intent to distrib-

DHS had been reviewing Guam's certification to issue REAL ID-compliant IDs, but that review has slowed, in part because of the "funding hiatus," Elizabeth Neumann, DHS assistant secretary for threat prevention and security policy, wrote in her Jan. 12 letter, referring to the partial government shutdown that has stretched for more than a month now.

"For the duration of this extension, through April 10, federal agencies may accept Guam-issued driver's licenses and ID cards for official purposes," Neumann wrote.

As part of the plea deal, Quenga agreed to make a full, complete and truthful statement regarding his involvement in criminal conduct as well as the involvement of all others known to him. He also agreed to testify at any trials or hearings.

# **FM skimmer arrives in Rome**

Nicola Marinelli, the Italian national who pleaded guilty to placing skimming devices on ATMs on Guam, arrived in Rome, Italy, last week as part of a federal removal order.

He is permanently barred from entering the United States, including

Marinelli was sentenced in early January to two years in prison but received credit for time served and the remaining balance suspended.

He also was ordered to serve two years of probation and 50 hours of community service.

However, he was later detained

by U.S. Immigration and Customs Enforcement and subjected to deportation proceedings.

#### **Arrested in August**

Marinelli was arrested in August 2018 after a Bank of Guam manager picking up pizza in Tamuning saw a man who matched the description of an ATM skimming suspect. Photos and surveillance footage released by the FBI had been circulating on social media.

According to the indictment, Marinelli installed scanning devices at Bank of Guam ATMs located in the Micronesia Mall and in a Subway restaurant in Agat.

He told authorities he had been recruited by someone with possible ties to organized crime in Italy, according to a magistrate's complaint.

Through an interpreter, Marinelli admitted to police he had been having financial difficulties, wrote Assistant Attorney General Monica Jo Aguon, in a declaration in support of the complaint.

The "defendant further admitted that a male known to him only as 'Michele' approached him in Italy and asked if he could place skimming devices on Guam," the declaration states. "Defendant indicated to police that 'Michele' might have connections to organized crime in Italy."

Marinelli told authorities he arrived on Guam on Aug. 1, 2018, with three skimming devices.
