US, China sketch outlines of deal to end trade war

WASHINGTON - The United States and China have started to outline commitments in principle on the stickiest issues in their trade dispute, marking the most significant progress yet toward ending a seven-month trade war, according to sources familiar with the negotiations.

The world's two largest economies have slapped tit-for-tat tariffs on hundreds of billions of dollars of goods, slowing global economic growth, skewing supply chains and disrupting manufacturing.

As officials hold high level talks on Thursday and Friday in Washington, they remain far apart on demands made by President Donald Trump's administration for structural changes to China's economy.

But the broad outline of what could make up a deal is beginning to emerge from the talks, the sources said, as the two sides push for an agreement by March 1. That marks the end of a 90-day truce that Trump and Chinese President Xi Jinping agreed to when they met in Argentina late last year.

Negotiators are drawing up six memorandums of understanding on structural issues: forced technology transfer and cyber theft, intellectual property rights, services, currency, agriculture and nontariff barriers to trade, according to two sources familiar with the progress of the talks.

At meetings between U.S. and Chinese officials last week in Beijing, the two sides traded texts and worked on outlining obligations on paper, according to one of the sources.

The process has become a real trade negotiation, the source said, so much so that at the end of the week the participants considered staying in Beijing to keep working. Instead

they agreed to take a few days off and reconvene in Washington.

The sources requested anonymity to speak candidly about the talks.

Commitments in writing

The MOUs cover the most complex issues affecting the trading relationship between the two countries and are meant, from the U.S. perspective, to end the practices that led Trump to start levying duties on Chinese imports in the first place.

One source cautioned that the talks could still end in failure. But the work on the MOUs was a significant step in getting China to sign up both to broad principles and to specific commitments on key issues, he said.

The United States has accused Beijing of forcing U.S. companies doing business in China to share their technology with local partners and hand over intellectual property secrets. China denies it engages in such practices.

Trump administration officials also object to nontariff barriers in China, including industrial subsidies, regulations, business licensing procedures, product standards reviews and other practices that they say keep U.S. goods out of

China or give an unfair advantage to domestic firms.

U.S. Treasury Secretary Steven Mnuchin has pushed for China to open its financial services markets to more foreign firms, including credit card giants Visa and MasterCard, which have waited years for China to make good on promises to allow them to operate there.

On currency, U.S. officials including Mnuchin have warned China against devaluing its yuan to gain a competitive advantage after the Chinese currency weakened significantly against the dollar last year, partly counteracting Trump's tariffs.

The two sides were discussing an enforcement mechanism for the deal, the source said. Reuters reported last month that the United States was pushing for regular reviews of China's progress on pledged trade reforms and could reinstate tariffs if it deems Beijing has violated the agreement.

The parties also were looking at a 10-item list of ways that China could reduceits trades urplus with the United States, including by buying agricultural produce, energy and goods such as semiconductors, according to two other sources familiar with the talks.

French TV cuts Facebook live feed from Jewish cemetery after abuse

PARIS - A French TV channel said on Wednesday it had been forced to cut short a live Facebook broadcast from a desecrated Jewish cemetery in eastern France because of an onslaught of anti-Semitic commentary.

Separately, two swastikas and anti-Semitic slogans were found painted in red on a monument at a different cemetery near Lyon.

"Our country is confronted with a resurgence of anti-Semitism undoubtedly without precedent since the Second World War." President Emmanuel Macron said later on Tuesday in an annual speech to Jewish leaders in France.

France 3 television said it went live from the first cemetery in the village of Quatzenheim on Tuesday as President Emmanuel Macron was visiting to pay his respects after more than 90 graves were vandalized with swastikas and anti-Semitic abuse.

But as it broadcast footage online to its more than 1.3 million Facebook followers, the feed was inundated with anti-Semitic commentary and abuse.

"We are talking about explicit death threats, comments that were openly anti-Semitic and racist, including 'Heil Hitler,' dirty Jew' or 'dirty Jews,' comments that were addressed at Emmanuel Macron and representatives of the Jewish community," the channel said in a statement explaining its decision.

"Within minutes, the number of vile and illegal comments had gone well beyond our capacity to moderate them," it explained, adding that it would have taken 10 or 20 staff to handle the onslaught.

"We refuse to traffic in hatred."

GRMC seeks dismissal of Bengzon lawsuit

The attorney for Guam Regional Medical City on Monday called on Judge Elyze Iriarte of the Superior Court of Guam to dismiss the request for a restraining order filed by former GMRC CEO Margaret Bengzon.

Attorney Todd Thompson told the court that Bengzon's claim "must be dismissed" because she did not have a contract with Guam Healthcare Development Inc. which does business as GRMC.

Bengzon is seeking reinstatement as chief executive officer of the "status quo" before she was ousted

"until such time as the issue of shareholder ownership may be resolved by the (Philippine) SEC or Philippine Courts."

'There is no remedy for contract breech," said Thompson, "because there is no contract."

Bengzon He maintained that Bengzon was an "at-will" employee at GRMC and that left her vulnerable to dismissal at any time.

"The presumption in the law is that an 'at-will' employment relationship is rebutted, and it hasn't been."

There "is no exception to the 'at-will' relationship," he argued. "Therefore, you haven't met your pleading burden.'

'Not the way to do it'

Bengzon's attorney, Phillip Torres, acknowledged that "there is no contract," but "that doesn't explain the

issue in this case," he said. The issue, he said, is "whether Ms. Bengzon has standing to be in this courtroom on the actions taken by the corporation."

"It's not an easy question," he said,

private hospital and a return to the exists," the attorney said, "unless that because Guam "does not have a well-developed employment law."

But, he argued, "clearly directors have fiduciary duties to each director ... and to remove somebody without giving them proper notice and send them a letter after the fact ... is not the way to do it."

He pointed out that nine of the shareholders of the Philippine parent company, Professional Services Inc., "have been indicted in the Philippines for fraud." And he maintained that the actions taken by those shareholders to remove Bengzon were not in accordance with the bylaws and already have caused harm.

served as editor-in-chief of the Marianas Variety newspaper before retiring in 2014.


