Circle K held its Craft Beer and Whiskey Festival on Saturday at the Sheraton Laguna Guam Resort.

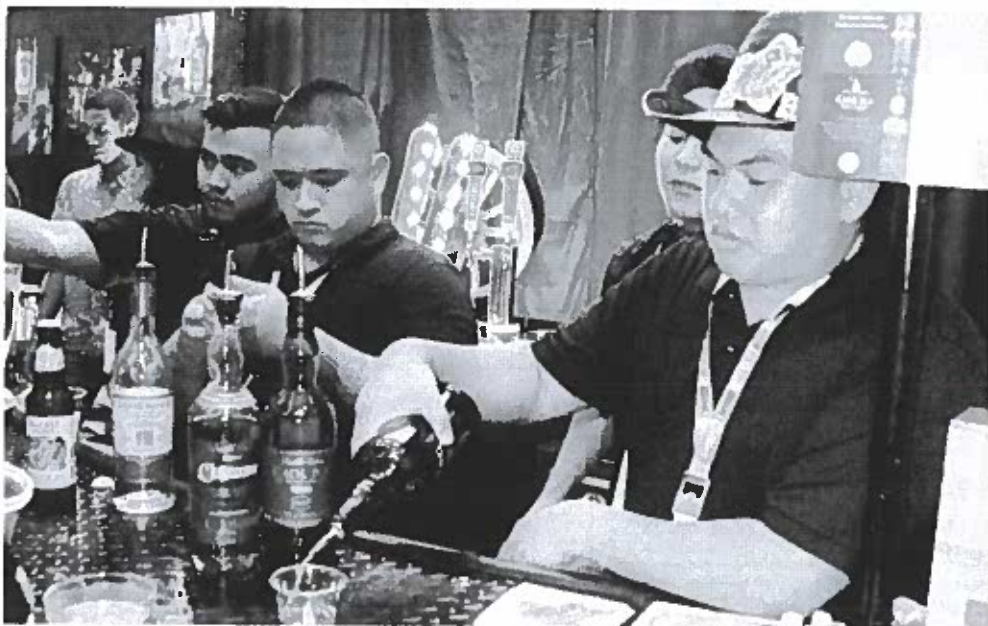
More than 70 craft beers were offered and 20 different whiskey labels were featured.

# Base commissary privileges extended to more veterans, caregivers

Beginning Jan. 1, 2020, a new law would allow Purple Heart and other military veterans access to commissary stores on military bases, including on Guam.

The law called the Purple Heart and Disabled Veterans Equal Access Act, became law as part of the John S. McCain National Defense Authorization Act for Fiscal Year 2019.

The federal law states access to commissary stores and base recreational facilities will be extended to:

- Purple Heart veterans;
- Medal of Honor recipients;
- veterans who are former prisoners of war;
- veterans with service-connected disabilities;
- eligible caregivers for veterans.

"A caregiver or family caregiver shall be permitted to use commissary stores and (Morale, Welfare and Recreation) facilities on the same basis as a member of the armed forces entitled to retired or retainer pay," the law states.

The Department of Defense will issue regulations that impose a user fee on individuals who are eligible solely under this section to purchase merchandise at a commissary store or MWR retail facility, the law states.

Over the weekend, Del. Michael San Nicolas posted a response that this law applies to Guam. He was asked about it on social media.

Hawaii Democratic Sen. Brian Schatz and Arkansas Republican Sen. John Boozman introduced the Purple Heart and Disabled Veterans Equal Access Act of 2018. It became law on Aug. 13, 2018.

"If you have the Purple Heart, you should also have access to the commissary. It's as simple as that," the Hawaii senator said when he introduced the legislation last year.

# Trump labels Republican presidential challengers 'the Three Stooges'

WASHINGTON (Reuters) - President Donald Trump dismissed three Republican challengers to his 2020 re-election as "the Three Stooges" on Monday and expressed doubt about ever agreeing to meet them on a debate stage.

"They're a joke. They're a laughingstock," Trump told reporters when asked whether he would agree to debate them during the 2020 nominating contest.

The Republican, who for years now has steadfastly refused to release his tax returns despite a long history of presidential candidates detailing their finances, also said he planned at some point to put out an "extremely

complete" statement on his finances.

He said the financial statement would make clear he does not need whatever revenue was produced when U.S. military personnel stayed at his Turnberry golf resort in Scotland while on refueling stops.

"I'm going to give out my financial condition, and you'll be extremely shocked that the numbers are many,

many times what you think. I don't need to have somebody take a room overnight at a hotel," he said.

Three Republicans - former South Carolina Rep. Mark Sanford, former Massachusetts Gov. William Weld, and former Illinois Rep. Joe Walsh - are mounting long-shot campaigns to deny Trump the 2020 Republican presidential nomination.

In a tweet, Trump recalled Sanford's controversial disappearance in 2009 when, while governor of South Carolina, he met his Argentine mistress under the cover story of having gone hiking on the Appalachian Trail, only to be found out later.

"The Three Stooges, all badly failed

candidates, will give it a go!" the president said. The Three Stooges were a vaudeville and slapstick comedy team whose antics regularly appeared on television.

Trump also denied having anything to do with the cancellation of Republican primary contests in four states, meaning he will face no opposition there. Cancelling their primaries were Nevada and South Carolina, which are critical early voting states, as well as Kansas and Arizona.

"The four states that canceled it don't want to waste their money. If there was a race, they would certainly want to do that," Trump told reporters on the South Lawn of the White House.

## Jury selection begins at Chinese woman's Mar-a-Lago trespassing trial

FORT LAUDERDALE, Fla. (Reuters) - A judge urged potential jurors to ignore their feelings about President Donald Trump's Florida resort, even if they "think it should be blown up," in order to fairly decide the fate of a Chinese national on trial for bluffing her way onto the property.

Jury selection began on Monday in the trial of Yujing Zhang, 33, before U.S. District Judge Roy Altman on charges of making false statements to a federal officer and trespassing on restricted property.

Zhang - whose arrest at the Mar-a-Lago club in Palm Beach in March while carrying multiple electronic devices sparked a probe as to whether she posed an intelligence threat - has made the unusual decision to defend herself at trial rather than use a lawyer. If convicted, she faces up to six years in a federal prison.

After she appeared confused about the trial in Fort Lauderdale, Florida,

Altman reprimanded her and urged her to work with assistant federal public defender Kristy Militello.

"I don't know why I'm here ... I think the trial has been canceled," Zhang said, speaking through a translator. "You're unprepared. You concocted that," the judge answered. "The trial is going to get very sophisticated very quickly ... I strongly recommend she step in as your lawyer today."

Potential jurors were questioned individually by the judge.

One was a man who identified himself on a written questionnaire as "a left-leaning Democrat," and Altman

told him that as a juror he would have to set aside his political opinions to render a fair verdict.

"Whether you like President Trump or don't like President Trump, whether you like Mar-a-Lago or think it should be blown up, or something in between," Altman said, adding none of that has anything to do with the case.

At the time of Zhang's arrest, in an incident that raised concerns about security at the Mar-a-Lago resort, investigators found in Zhang's possession four cellphones, a laptop computer, an external hard drive device and a thumb drive, the Secret Service said in a court filing. Initial examination of the thumb drive determined it contained "malicious malware," the Secret Service said.

After the trove of electronics was found on Zhang, a search of her Palm Beach hotel room reportedly uncovered a device meant to detect hidden cameras and nearly \$8,000 in cash.

## Rescuers seek fourth crew member on stricken SKorean ship

(Reuters) - Rescue workers on Monday freed three of four missing crew members from a South Korean cargo vessel that flipped on its side off the coast of Georgia, the U.S. Coast Guard said.

Salvage crews gradually drilled an opening in the ship's hull, first to deliver food and water to the survivors, then to extract them, USCG Capt. John Reed told a livestreamed news conference.

The fourth missing crew member was trapped behind a glass panel in the ship's engineering control room, and though rescuers could see him, they had yet to get him out, he said.

"He's at greatest risk ... right now," said Reed. "We are trusting that the ventilation in there remains intact."

The fourth crew member has yet to get any food or water around 36 hours into his ordeal. Temperatures for rescue workers on the hull of the ship rose to 120 Fahrenheit and Reed believed it was even hotter inside the ship.

Asked about the condition of the three rescued crew members, Reed said two of them were able to walk off the hull of the ship and get on a tugboat. All three were taken to hospital.

"Their condition is relatively good for having spent 34 or 35 hours in the conditions they were in," Reed said.

He declined to comment on what might have caused the vessel to tip over as it transported cars.
