



**AN ACT TO AMEND § 12212(g) OF ARTICLE 2, PART 1,
CHAPTER 12, TITLE 10, GUAM CODE ANNOTATED,
RELATIVE TO ENSURING THAT PERSONS OR
ENTITIES WHO HAVE REPORTED ARE PROMPTLY
INFORMED OF THE GUAM BOARD OF MEDICAL
EXAMINERS' ACTIONS AND DECISIONS.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** § 12212(g) of Article 2, Part 1, Chapter 12, Title 10, Guam Code
3 Annotated, is hereby *amended* to read:

1 “(g) The Board shall promptly acknowledge all reports received under
2 this Section through phone call and email within seventy-two (72) hours, or
3 through certified mail within seven (7) working days. Persons or entities
4 reporting under this Section shall also be promptly informed through phone call
5 and email within seventy-two (72) hours, or through certified mail within seven
6 (7) working days of the Board’s actions, decisions, and final disposition in the
7 matters reported.”

8 **Section 2. Effective Date.** This Act shall be effective upon enactment.
