X	<p>Rules & Regulations</p> <p>A. Proposed Legislation and Rules and Regulations — Bill 356-36.</p> <ol style="list-style-type: none"> 1. The Chair reported that the Proposed Legislation and Rules and Regulations had gone through three public hearings by the GBAHE and one public hearing by the Legislature. The GBAHE noted that Bill 356-36 was expected to be heard by the Legislature today, 12 December; however, there was indication as to whether it made on the agenda. 2. In reference to N. Cepeda's request for clarification of the Examination for Professional Practice in Psychology (EPPP), Asst AG Weinberg provided some background of the EPPP, as determined by the Association of State and Provincial Psychology Boards (ASPPB), who now requires two examinations: EPPP-1 (Knowledge) and EPPP-2 (Skills). He stated that the GBAHE was one of the jurisdictions that was very proactive in making and approving the EPPP-2 requirement in December 2019 as a requirement for licensure for clinical psychologists even before the EPPP-2 was available, then the pandemic began. Since the Board's approval, only two or three applicants obtained the clinical psychologist license without having to take the EPPP-2. 3. Wayne Butler, who was advocating on behalf of his son, Alan Butler, had sent a letter to the Governor, the Legislature, and others, stating that his son should not have to take the EPPP-2 since there was no evidence of a change in the licensure requirements through an announcement or a change to the application or checklist. Asst AG Weinberg stated that he looked into the matter and confirmed there was no public notification or changes to the application process indicating that the EPPP-2 would become effective at a certain date. 4. XI	<p>also address the criticism of the HPLO Boards of not duly informing the public of changes or important information. For clarity and fairness, he suggested maintaining the current proposed approach to implement the EPPP-2 until July 2023 and allow the administrative adjudication process to take its course. There are some other issues that have recently come forward that may require additional clarification by the Board; however, he is hopeful that the legislation and rules and regulations are, first, adopted, with subsequent clarification to be provided by the Board to the Legislature on the issues being raised.</p> <p>5. Asst AG Weinberg stated that the EPPP-2 would not be required by Alan Butler. The Chair stated that she disagreed. She stated that she was at the ASPPB meeting on 25 October 2022 and EPPP-1 and EPPP2 has always been part of the agenda, where Guam adopted the requirement for the EPPP-2 early. When going on the ASPPB website, Guam is listed, so when an application completes and passes the EPPP-1, EPPP-2 is listed as the next step. Therefore, since the Board approved the EPPP-2, it should now be required. Otherwise, it questions the Board's authority and integrity. Asst AG Weinberg stated that the Board approved and released the drafts to the Legislature in its current form, which lists the effective date of the EPPP-2 requirement, so what the Board decides to do at this point in time is solely up to the Board.</p> <p>A.
