- HPLO Deborah Borja and I met with Tommy Taitague, DPHSS ASO, on 12/14/2021, to try to learn how GBAHE fits into the funding picture. It will take more than one visit for me to fully understand the complexity of how it all works.

-Take Away: There are unfunded mandates that DPHSS is faced with having to use funding previously earmarked for HPLO/Boards.

-I had advised that the current way of using 5 years in the estimated computation of GBAHE's projected revenue is not a good reflection since we have renewals of licenses on the even years. I recommended using 4 or 6 years of financial revenue data instead.
