

## Notice of Opportunity to Request Public Hearing on EPA's Approval of Guam's Program Revision

The U.S. Environmental Protection Agency (EPA) is announcing its approval of revision to Guam's approved primacy program, the EPA-approved program that oversees public water systems in Guam. Guam has adopted regulations that effectuate the federal Revised Total Coliform Rule, and EPA has determined that these regulations are no less stringent than the corresponding federal regulations.

Any interested person may request a public hearing on EPA's determination. The deadline for submitting a request for a public hearing is 30 days after the publication of the Federal Register Notice related to this action (see below for more information). The request must be addressed to the Regional Administrator (RA) of EPA Region 9, via the following email address: R9dw-program@epa.gov.
