He stated that letter of assurance should be sent to these establishments to inform them about the rules regarding their scope of practice. Another issue that was brought up was that of the unauthorized selling of oriental medicine in markets. Environmental health will be consulted regarding the sell of oriental medicine. The Board mentioned a concern with the establishment called "360" that may be practicing without proper licensure. Dr. Miller raised concern about wellness businesses that are providing massage services that require no education. Dr. Miller is worried that some of these businesses might begin to expand their scope of practices without the proper clearances or licenses.  The Chair stated that the statute requires acupuncture and oriental medicine to by licensed by the Board. Dr. Miller suggested that certified mail be sent to establishments that are violating the statues, issuing a cease-and-desist order. Press releases are also being worked on by HPLO.  The Board raised a need to investigate, perhaps alongside the Board of pharmacy and inspectors, regarding markets selling "oriental medicine".
