He has significant experience in animal surgical research, preclinical medical device testing, laboratory animal medicine, and animal welfare consultation, with over 40 scientific publications. 		a. The case involved a kitten brought to the veterinarian's clinic, which subsequently died under her care. Dr. Litwack concluded that the veterinarian failed to properly diagnose and treat the kitten, did not provide adequate pain relief for a fractured limb, improperly treated an infected wound, and did not give the owner adequate care instructions. Additionally, the veterinarian withheld the patient's records from the owner until her bill was paid, which is unethical. The records provided were also found to be inaccurate.			
		b. The Board discussed potential actions, including no action, suspension with penalties, or revoking the veterinarian's license. The veterinarian had responded to the initial complaint but had not seen Dr. Litwack's conclusions. The Board must decide on a sanction and inform the veterinarian, who will have the opportunity to respond. If she disagrees with the Board's decision, she can appeal the ruling, involving legal representation. The Board also noted other complaints against the veterinarian and decided to table the current case until further discussion, considering the other complaints as well.
