“This will help tourism and influx our economy and help bring tourists back to Guam,” said Shimizu. “People think we’re nuts, but it’s part of a big plan. (The Guam Visitors Bureau) supports us and is our biggest sponsor. The

whole staff there saw our vision and never stopped believing in this. We were thinking we’d maybe get 250-300 competitors, not at all thinking we’d sell out at 700. But we’re giving tickets to Guam every year, so I wouldn’t be surprised if it sells out every year.”

Alvarez said his most memorable volleyball moment dates back to his sixth-grade year, when he was a B-team player. He served an ace to close out his team’s first set win that season.

“I thought I nailed it, but turns out it was a lollipop serve that hit the net and just trickled over for an ace,” he said. “I finally got an ace, and we finally won a set. That’s what got me hooked onto volleyball.”

His backyard court was built by his father Alvin Alvarez, who also played volleyball for FD and beyond in the 90s.

“I honestly think he’s why I hit and pass the way I do. My dad’s just an incredible player,” said Ethan Alvarez. Then he laughed. “I really aspire to be like him — even though I can jump higher than him, and hit harder than him. He’ll always be the No. 1 setter no matter who I watch anywhere. Dad, you’re the reason I’m here. I love you.”
