

# Acdavate hands Lady Tritons first loss

The University of Guam Lady Tritons suffered their first loss during the Lady Triton — Global Learning Super League, falling to Team Acdavate Wednesday night at the UOG Calvo Field House.

Acdavate defeated the Lady Tritons 77-68, according to a news release from UOG's Triton Athletics. In an earlier game, Fuetsa by BioSteel defeated the BallHers 71-63.

Acdavate took the lead in the first quarter, 22-16, and used their calculative defense to prevent the Lady Tritons from coming back. The team continued to lead during the second quarter with Arriah Arceo scoring nine points for the team, according to the release.

In the second half, the teams were evenly matched. An Acdavate player was ejected from the game for dropping one of the Lady Tritons players in the third

quarter, according to the release.

Arriah Arceo and Arri Arceo led Acdavate with 29 and 21 point, respectively. Amanda Ungcango scored 17 points for the Lady Tritons, according to the release.

Acdavate and the Lady Tritons are both 3-1 in the league.

## Fuetsa

The BallHers took an early 23-10 lead. However, Fuetsa quickly passed the BallHers and led 33-27 at the end of the second quarter.

Fuetsa was ahead 47-46

after the third quarter and extended their lead to win 71-63, according to the release.

Nana Watanabe led Fuetsa with 21 points while Nic Perez and Angeli Dacanay scored 15 and 13 points, respectively. Angelique Sahag scored 19 points for BallHers while Alana Salos and Zyla Soriano each scored 15 points, according to the release.

The Lady Tritons play the Lady Bombers at 1 p.m. Saturday while Acdavate faces Fuetsa by BioSteel at 4:30 p.m.
