VIII	<p>F. POLICE & COURT CLEARANCE.</p> <p>The Chair stated that applicants have been required to submit court and police clearances as part of their initial applications. For subsequent renewals, an applicant's attestation was accepted (e.g., in lieu of submission of court clearances). The Chair inquired if the Board should require updated clearances for renewal applications. A. Mariano suggested seeking advice from legal counsel, especially since approval of an application would be dependent on the type of violation identified in the police or court clearance. The Chair stated that the Board had been previously advised by legal counsel that criminal, as well as civil cases, could give reason to deny an application, e.g., moral turpitude.</p> <p>B. Hattori-HPLO stated:</p> <ul style="list-style-type: none"> • GBNE requires police & clearances for initial & renewal applications. ✓ • GBME does not require clearances but relies on the National Practitioner Data Bank report; ✓ however, this issue will be re-addressed at its August 2023 meeting. • Other HPLO Boards will also be addressing this issue to better standardize the requirements, which may require changes to the Rules and Regulations and Legislative approval. ✓ • There are a lot of off-island applications, and some states do not require police and court clearance. ✓ • On-line background checks could be an alternative which could be included into the rules and regulations.
