VIII Announ	ncements	During a discussion that followed a recap of the meeting, which was necessary due to a technical issue with the audio, Z. Pecina inquired about the necessity of requiring the CSR, given that the DEA is the overall authority and the requirement is embedded in the law. She noted that the law could always be amended and mentioned that in most jurisdictions, the DEA's authority suffices without the need for local	GBEP		Set Date
		CSRs. M. Gabriel responded by acknowledging that the requirements vary by state, with some states maintaining both a local CSR and DEA oversight.

		A. Mariano explained that certain states do not require a local CSR to dispense controlled medication. However, he expressed concern that removing the local CSR requirement could complicate the process when establishments apply for a new license. While the GBEP conducts the initial inspection, the U.S. DEA might not be willing to inspect the controlled substances portion, leaving that responsibility to the local CSR, which typically handles inspections for controlled substances. He also noted the absence of a local U.S. DEA officer, with the nearest one located in Hawaii. Z. Pecina sought clarification, confirming that an inspection, not just a certificate, is required when applying for the DEA. A. Mariano confirmed this, adding that once an establishment receives the local CSR, the U.S. DEA relies on the local inspection report. Z. Pecina then raised concerns from medical staff and advanced practice nurses about the need to pay for both DEA and CSR licenses when the CSR adheres to the same laws as the DEA, particularly for dispensing purposes, while acknowledging the potential issues related to distribution inspections.			
		Z. Pecina suggested that the law might stipulate the requirement for establishments to have a CSR, but questioned whether practitioners could simply rely on the DEA license. She indicated that this might be appropriate. A. Eustaquio then inquired whether the Divsion of Environmental Health, which issues the CSR, had been consulted and asked about their stance on the matter. Z. Pecina confirmed that they were in favor of it because it generates revenue for them. M. Gabriel sought clarification on the necessity of requiring individual licensees to obtain a CSR. Z. Pecina reiterated that it seems unreasonable for practitioners to pay for both the DEA and CSR when they operate under the same laws, which is why many jurisdictions have eliminated the local requirement for practitioners, leaving the dual fees applicable only to establishments, not individual practitioners.			
		It was noted that some physician assistants are only authorized to prescribe medications under the local CSR for schedule four and five substances. Z. Pecina acknowledged this point, and M. Gabriel clarified that these limitations are imposed by state regulations, not by the DEA, as the DEA defers to state laws on such matters, including prescribing restrictions. Z. Pecina then expressed concern that this could disadvantage physician assistants under the current system. M. Gabriel agreed, pointing out that the DEA does not impose these restrictions, as it is a state licensing issue, and in some states, the CSR defines the prescribing limits rather than the DEA. Z. Pecina expressed regret that the issue wasn't addressed when the Division of Environmental Health increased their fees, which are now significantly higher than what the DEA requires, and suggested that they consider advocating for a revision of these payments. The discussion concluded with thanks and a sense of closure. Announcements – Next Meeting – September 19, 2024, at 07:30 am.
