# First murder trial begins in Alvarez case

"Keep on, keep on, keep Assistant Attorney General Sean Brown said as he opened the prosecution's case against A-Last Amanto Simiron, one of two men accused in the February 2017 murder of Gilbert Alvarez Jr.

"These words are very important," Brown said as he addressed the jury Tuesday in the Superior Court of

They are "the words used by the defendant, A-Last Amanto Simiron, when he instructed his friend. Mallo Sally ... to hit Gilbert Alvarez Jr. in the face and head with a metal pipe."

Brown accused Simiron of holding Alvarez in a choke hold while Sally beat the victim, adding they left Alva-

rez "face down in a puddle of his own blood on the side of the street at nighttime."

Simiron and Sally are facing charges of aggravated murder. Simiron's case is the first to go to trial.

First on the stand Tuesday afternoon was Guam police detective Jeremiah De Chavez, who testified that he obtained a written confession from Simiron. He said the defendant also agreed to a videotaped re-enactment of the crime.

"What happened to Gilbert Alvarez was a tragic loss of human life," Brown said. "Now it's time for justice."

Alvarez was 43 years old when he agreed to give Simiron and Sally a ride in his pickup from the Mangilao baseball field in the early morning hours of Feb. 24.

Alvarez was found unconscious, lying face down on the ground on President's Lane near the University of Guam. He was later pronounced dead at Naval Hospital Guam. His pickup truck was found later in Yigo, crashed into the jungle.

Chief Medical Examiner Dr. Aurelio Espinola concluded Alvarez died from a skull fracture.

Simiron's defense attorney, James Spivey, reserved his opening statement until the close of the government's case.

The trial resumes today in the courtroom of Judge Maria Cenzon.

filing jointly."

The tax return for Aguon and his wife, Jennifer Aguon, shows their combined taxable income was \$133,224, with taxable interest of \$613 in interest and dividends from Coast 360, Bank of Guam and the CFCU.

The return shows an \$8,082 loss on Line 17 for rental real estate, royalties and partnerships, along with \$12,700 in itemized deductions on Line 40 for a taxable income of \$104,955.

The Aguons paid \$17,716 in taxes to the Department of Revenue and Taxation in 2017.

It has been customary for U.S. presidential candidates to disclose their tax returns, with the exception of President Donald Trump's refusal to disclose his in the 2016 election. However, it hasn't been a practice here on Guam.

# **UOG** polls show Leon Guerrero in the lead

Two phone surveys conducted by students in a data analysis class at the University of Guam showed Democratic gubernatorial candidate Lou Leon Guerrero pulling ahead of the pack.

The first survey, conducted Oct. 12, showed Leon Guerrero was the choice of 158 respondents, followed by Republican Ray Tenorio with 85, and "other" with 13. About 280 residents were surveyed.

A week later, after the Oct. 13 announcement that Sen. Frank Aguon Ir would run with Alicia Limitaco as a write-in team, Leon Guerrero still kept the lead with 137 survey respondents favoring her. Tenorio trailed further with 77, and "write-in" received the support of 24 of the surveyed residents.

The survey had a margin of error of plus or minus 5 percent.

The students' surveys were led by Patrick Pocaigue, said their professor, Ron McNinch.

With two weeks before the election, McNinch said there's no guarantee the outcome will be the same during Election Day.

He said past elections have shown what's called "the curse of the frontrunner." That means a frontrunner and his or her supporters get too confident too soon, he said.

This survey has been conducted under his guidance for 22 years.

on Guam while his suspension by USA Table Tennis for alleged sexual misconduct stands. The suspension is for a case involving an adult, but no other details were available. USA Table Tennis is the nonprofit governing body for table tennis in the United States.

Hours after the Post reached out to the Guam Table Tennis Federation on Sunday, the organization decided to hold off on its association with Hyatt.

"We had instructed Hyatt if the allegations were untrue to immediately return stateside to resolve the issue," Narci Ji, the Guam Table Tennis Federation secretary-general, said in a written statement.

'Upon clearance, he is welcome back to GTTF. Meanwhile, GTTF will not endorse the efforts of Hyatt, nor is (he) allowed to use the GTTF name (or) logo," Ji stated. "We wish Michael the best of luck and we have no further comments.

#### Olympic experience

The 48-year-old former Olympian represented Jamaica in table tennis in the 1992 Barcelona Games and the 1996 Atlanta Games. Hyatt remains suspended from playing in USA Table Tennis tournaments until Sept. 1, 2019, and isn't eligible to coach until Sept. 1,

"He was suspended on the 30th of August, 2016, and he was suspended by a hearing panel because of certain allegations that were made under our SafeSport policy," said USA Table Tennis CEO Gordon Kaye, "The results of the hearing panel are not public," Kaye said, but did confirm "it was a violation of our SafeSport policy for sexual misconduct not involving a minor."

The sexual misconduct complaint was handled by USA Table Tennis rather than by law enforcement authorities.

"At the request of the complainant, the matter was handled as an internal USATT matter, under our SafeSport policy," said Kaye, who also is the organization's secretary-general.

The hearing panel determined the length of the suspension, and the cause of the suspension," Kaye said. Kaye holds the additional role of being the North America president for the International Table Tennis Federation.

Hyatt denied sexual misconduct was the reason for his suspension by the table tennis governing body.

"That's a nonissue," Hyatt said. "There is nothing true. There is an issue I had with the president of the USA Table Tennis about some sponsorship money I secured for them two or three years ago, that they didn't acknowledge that I helped them with. I was set up. When I approached him about the money, and they didn't comply, they suspended me."

"There is no sexual misconduct involving an adult," he added.

#### Training events

Hyatt first came to Guam for a table tennis training camp in 2015 but returned to California.

In September 2018, he came back to Guam, this time to stay, he said, after obtaining a Guam driver's license.

Since the Guam Table Tennis Federation hired Hyatt, the former Olympian had been out in the community, holding training events at the Agana Shopping Center and for certain schools.

His entry into Guam's close-knit community came with big promises. including that he would prepare someone to be a table tennis Olympian.

"Between now and then, I am going to produce players and get them ... to the level where they can qualify for the Olympics," Hyatt said. "We're going to go there (the Olympics) and create history."

At the Tinian International Airport, only military and humanitarian aid operations are allowed.

#### Rota

The airport and seaport on Rota are open. They suffered minimal damage.

#### **Tourists**

The first 150 of more than 3,200 stranded tourists were flown out on Saturday. The Commonwealth of the Northern Mariana Islands government has been in touch with several commercial carriers to arrange for the remaining tourists to be flown back to their countries of origin.

It's hoped that all remaining tourists will have been evacuated by Monday. according to the recovery update.
