## Crusaders defeat Tritons in amateur baseball

The University of Guam Tritons suffered an upset when the Crusaders defeated them in the Amateur Baseball League.

The Crusaders won against the Tritons 7-2 on Sunday at the Triple J Baseball Complex at Okkodo High School, according to a release from UOG's Triton Athletics.

It was a slow start for both teams as they were scoreless till the second inning. By the top of the third, the Crusaders struck for three runs behind the two-run single by the

team's DC Nena. Nena was coming off starting Tritons' pitcher Kyle Martinez with third run coming on a passed ball, according to the release.

The Tritons finally scored in the bottom of the fourth after O'Neil Yobeck reached first on an error. He later stole second and had a single.

The Crusaders returned at the top of the fifth with a walk and two singles to score their fourth run off of Triton relief pitcher Rico Minor. The team continued to lead on top of the sixth with two hits, two walks, a

hit batter and an error by the Tritons, according to the release.

The Tritons were able to score again by the bottom of the sixth, according to the release.

Kyle Martinez took the loss for UOG while Florincio Inuya got the win. Andrew Perez led the UOG offense with a double and an RBI. AJ Benavente had two hits for the Crusaders and scored two runs, according to the release.

The Tritons are set to return to face the Eagles at 3 p.m. Saturday at the Triple J Complex.
