The Office of the Federal Public Defender for the Districts of Guam and the Northern Mariana Islands is accepting applications for a full-time Assistant Federal Public Defender position to be based in the Guam office. This position is for a licensed attorney. The ideal candidate must have graduated from an accredited law school and be a member in good standing in all courts in which admitted to practice, but a Guam bar license and knowledge of Ninth Circuit case law is strongly preferred though not required; litigation experience; writing and advocacy skills; the ability to work in a team environment; at least 3 years of criminal experience; and must be a United States citizen or eligible to work in the United States. Appointment is subject to a satisfactory background investigation.
