	-During the meeting, Yang H. Kim was discussed regarding some missing			
	documentation from a previous session. It was confirmed that the			
	background check, which had been an issue, was now received and			
	satisfactory. Concerns were raised about Yang H. Kim's licensing,			
	specifically referencing prior issues with the California Dental Board,			
	including a suspension or probation status. It was noted that these issues had			
	been adjudicated, and he had undergone necessary programs and education			
	to rectify his standing.			
	Overall, it appears Yang H. Kim is currently in good practice standing and			
	has completed the required documentation. However, there was uncertainty			
	regarding potential grounds for granting permission for clinical exams based			
	on his past history with the board. Additionally, it was mentioned that he had			
	faced accusations related to overshadowing planning and incurred a fine of			
	\$5,000, with the adjudication of those cases dating back to around 2014. The			
	board continued its discussion regarding Yang H. Kim, noting that his			
	reinstatement took place about three years ago, indicating he has been		l i	
	actively practicing for the past seven years. Concerns were raised regarding			
	potential licensing issues that existed at the time he applied for the exam in			
	Guam. Specifically, there was uncertainty over whether he had disclosed any			
	prior issues in his sworn statement during the last application process, as			
	failing to do so could lead to significant complications. The group reached a			
	consensus to review the relevant Guam documentation to verify the accuracy			
	of the information he provided. Additionally, there were brief interruptions			
	regarding checking past records, but the meeting participants agreed to		[
	revisit this discussion later. The discussion continued regarding Yang H.			
	Kim, noting that his reinstatement occurred approximately three years ago,			
	which means he has been practicing for the past seven years. It was			
	highlighted that these licensing issues were present at the time he applied for
