Mr. Sapp was not physically present during the service due to emotional distress but maintained communication throughout. While he was within the premises but not inside the salon, the GBBC noted that the apprentice received approval on 4 December but attended to the client on 14 October; the Chair stated that the individual was not permitted to perform any services, which is a violation. After Mr. Sapp departed the meeting, the GBBC will deliberate on appropriate actions to take. This will involve an examination of the application dates for both Mr. Sapp and the implicated apprentice. After the investigation, the GBBC may seek guidance from the OAG, if necessary; however, the Board is empowered to decide on consequences regarding the standards of practice. The Chair stated that the establishment and the licensed individual signing for the establishment, who permitted an unlicensed individual to perform a service, is subject to violation. Contact will be made with the apprentice for a statement, and it was observed that he failed to retrieve his license, which raises question on whether he has a health certificate and sanitary license and subjects him to a violation.
