- (1) Independent Use of the following therapeutic pharmaceutical agents for topical preparations: *on-going discussion to add*:
 - a. Anti-inflammatories
 - b. anti-allergic
 - c. anti-infectives
 - d. topical hyperosmotic
 - e. anti-parasitic agents (tea tree)
 - f. astringents/antiseptics (betadine)
 - g. Any combination of the above agents
- (2) Co-management with an ophthalmologist, additional agents may be utilized: on-going discussion to add:
 - a. oral anti-allergics
 - b. oral anti-infectives (antibiotics, antivirals, antifungals)
 - c. oral analgesics (ibuprofen, acetaminophen, naproxen)
 - d. oral topical anti-inflammatory (steroids, ibuprofen)
 - e. topical and oral anti-glaucoma agents
 - f. topical anti-inflammatories
 - g. emergency use agents (Diamox, epipen, apraclonidine, beta blockers)
 - h. Any combination of the above agents
- (3) Independent use of all Diagnostic agents on-going discussion
- (4) Adding epilation, foreign body removal, concretion removal, pseudo membrane removal, suture removal (J. McDonald, O.D. Member pending on response)
- (5) Add CPR All therapeutic OD are required to have current CPR certificate - equivalent to the American Heart Association BLS Healthcare Provider Course. Certificate will be submitted during license renewal. TABLED
- (6) Accepting National Board Part III in lieu of Practical and adding law exam.
 - a. Revise practical for applicants who did not take National boards; add law exam for applicants
 - b. Remove Radioscope from Practical
