Board informed R. Tingson a receipt of registration does not suffice as actual attendance to the workshop. R. Tingson stated that he has video documentation that he did attend and hasn't received the email from the workshop yet. He stated the people from the workshop said it will take a couple of weeks to send the email out. R. Tingson attending the NACCAS workshop has the intention to keep his school open.</p> <p>R. Tingson reported he has six (6) months to apply for candidate status, but he is not applying right now because if he did, he would have to turn in a yearly survey by November 30th. He wants to wait until December or January to apply for candidate status. Board is requesting R. Tingson to submit a Certification of Completion for attending workshop. R.
