Mariano proposed amendments to the July 18 minutes, specifically referencing item number three, which concerned the approval of the minutes. He highlighted that the last item involved a transition ratio of five to one, suggesting that this should be updated once the new pharmacist becomes operational. Additionally, he pointed out that on the last page, number six, the final item about the website setup should pertain to the pharmacy rather than medicine. A. Mariano proposed amendments to the August minutes, noting that board member J. Caruso was absent. He referred to page eight, specifically the last paragraph, stating that it incorrectly mentioned some physician assistants being authorized, whereas it should clarify that all physician assistants are authorized. <i>Motion to Approve as Amended: M. IV	<p>HPLO Administrator's Report Z. Pecina delivered the administrator's report, announcing that J. Caruso had officially resigned from the board, effective immediately, and that the resignation had been submitted to the governor's office for their awareness. She encouraged board members to provide any recommendations for a replacement,</p>	Z. Pecina	0756	Noted

	<p>mentioning that applications could be sent to potential candidates for submission. M. Gabriel noted that there had been a previous application from K. Lee. In response, Z. Pecina stated that she would follow up with the governor's office to confirm whether the existing application could be used or if a new one would need to be submitted.</p> <p>Z. Pecina continued her report, informing the board that they currently consist of five members and referencing the NPDB's recommendation that the board consider including a public member as part of their composition. She explained that if a public member were added, the board would need to think about maintaining an odd number of voting members. Z. Pecina mentioned that the updated user regulations already include a certified technician, keeping the board at five members, with four pharmacists and one technician. If a public member were added, the board would increase to six members, but the public member could be designated as a non-voting participant to maintain an odd number for voting purposes. She emphasized that this recommendation aligns with a broader regulatory trend across boards, as most other boards already include public members, with pharmacy being an exception.</p> <p>Z. Pecina also addressed disciplinary cases, reporting that there are currently two complaints on record, one of which has been assigned to juries. She suggested that the board either reassign the case or contact juries for an update on the status. Regarding the board's rules and regulations, Z. Pecina noted progress, mentioning that all administrative items have been incorporated, and encouraged the board to aim for completion by the end of the month, as they were down to the final ten pages. A. Mariano added that, concerning the two complaints, the board has reached conclusions on the findings, but they are awaiting a formal letter from the legal office to be submitted to the board.</p>
