	<p>the positive signs of improvement and noting the limited number of CNA programs available on the island. A. Varghese requested input from Z. Pecina and the board members on this recommendation.</p> <p>G. Woodard agreed with A. Varghese's assessment, highlighting the limited availability of nursing or CNA programs and acknowledging the improvement shown by GMTCC. G. Woodard supported the recommendation to extend the probation for another year, as it would not hinder the program's progress. C. Huntsman inquired about the specific criteria GMTCC needs to meet. A. Varghese clarified that GMTCC must demonstrate improvement in student outcomes, including pass rates. While there has been a significant improvement from the previous year, GMTCC has not yet achieved the current standard of an 80% pass rate. A. Varghese mentioned that the University of Guam currently does not have a CNA program, leaving GCC and GMTCC as the only options on the island. A. Varghese also noted that although GMTCC's performance has improved in terms of pass rates and enrolment, it still falls short of the required standards. Additionally, there is a possibility that the standard may be revised to a 75% pass rate in the future, pending approval, but for now, it remains at 80%.</p> <p>Z. Pecina added that the issue with GMTCC might not be student failure but rather that students are not taking the exam, which negatively affects their outcomes. Z. Pecina suggested the need to meet with GMTCC to discuss their plan for encouraging students to take the exam. Z. Pecina expressed agreement with the recommendation to extend the probation for another year, particularly in light of the observed improvements, and noted that this would be beneficial for the community. However, Z. Pecina also recommended continued monitoring of GMTCC, proposing that they submit a midway report to the board in addition to their annual report. <i>Motion to Continue Probationary Status: A. X	<p><b>A. Initial Application</b></p> <p><b>1. Jessica Michelle Bollinger, RN</b>  Jessica Michelle Bollinger, RN, requested a single state license. The request was not approved at the initial level due to a misdemeanor she received on July 17, 2023. J. Bollinger will be monitored from July 17, 2023, to July 17, 2025, and was required to complete several conditions: a victim impact panel, a breath test, random urinalysis, 80 hours of community service, and a fine of \$2,255. There is no evidence indicating that these conditions have been completed, and judgment may not be finalized until 2025. Despite this, the applicant claims to have fulfilled all requirements. J. Bollinger is requesting a single state license from Guam as she no longer qualifies for a multi-state license, which she previously held in New Mexico.</p> <p>G. Ramos inquired whether there was written proof of J. Bollinger's completion of her probationary requirements. Z. Pecina confirmed that J. Bollinger had verbally indicated completion of the requirements. D. Belong responded that Evaluation Services had verified that J. Bollinger completed the requirements.</p> <p>Z. Pecina noted that in other states, individuals on probation often need to obtain approval from their state board to hold a second job, and such provisions are generally strict, as seen in places like California. Z. Pecina suggested that reaching out to the Oregon State Board of Nursing could provide clarity on whether similar restrictions should apply. G.
