Hayahay, a cosmetologist, stating that if her practice is limited strictly to aesthetics—services that cosmetologists are permitted to perform—there should be no issue. A. Taitano agreed and noted that this was also a concern she intended to address. She mentioned that P. Hayahay's intended place of work is a spa that exclusively offers aesthetic services. A. Taitano shared the same viewpoint as M. Tiong, suggesting that as long as the salon does not offer hair services and only provides spa services, an esthetician would be an appropriate supervisor for P. Hayahay in this case. 		2. Daryen Guerrero – Cosmetologist M. Tiong raised a concern about Daryen Guerrero, a cosmetologist, who will be apprenticed under a barber. She emphasized that as long as D. Guerrero is apprenticed under a barber, he should not perform any chemical services, as barbers are not permitted to offer these services. M. Tiong stated that D. Guerrero can continue his training in cosmetology while practicing under barbering conditions, provided he does not engage in chemical services. A. Taitano supported this view and added that D. Guerrero should be informed that certain barbering services, such as shaving and straight razor shaving, are not permitted for cosmetologists. She agreed that D. M. Tiong noted that the regulation stipulates that any applicant who fails to retake and		
pass the required exams will forfeit their apprenticeship and must retake the entire		
exam. She mentioned that several applicants who have not reapplied to retake the		
exams are affected by this rule. M. Tiong recommended that since many applicants are		
reapplying to take the exams and the exams are written, the board could consider		
issuing apprenticeship licenses on a provisional basis. This would allow the applicants		
to begin their apprenticeship while awaiting their exam results. She suggested that if		
the board is willing to take this approach, it would be discussed further.

A. Taitano proposed issuing a six-month apprentice permit to allow sufficient time for		
applicants to take the exam at least once. She raised concerns about coordinating the		
timing for the exam, particularly with the upcoming live testing, and sought

	suggestions on how to determine the end date for the permit. She questioned whether to extend the current permits or issue new apprentice licenses. R. Santos responded that instead of extending permits, it would be more practical to keep the existing permits valid until the applicants receive their test results. This would provide grace to those who are already over the permitted apprenticeship duration according to the regulations.			
	M. Tiong suggested that extending the apprentice permits could be an option since the regulation states that if an applicant does not retake and pass the exam, they will forfeit their apprenticeship and be required to retake the entire exam. She acknowledged that applicants would likely prefer to avoid retaking the full exam. Therefore, implementing an extension could motivate them to complete the exam requirements. This extension would encourage applicants to take the exam within a specified timeframe, helping to ensure they comply with the necessary regulations.			
	M. Tiong recommended a three-month extension for apprentice permits, which she believes is reasonable. She noted that some candidates reapplying for exams and apprenticeships have held their licenses for over two years, with some extending back as far as ten years. According to the regulations, applicants who fail the exam a second time are required to enroll in a refresher course, which is not being mandated in this case since the exam is written. M. Tiong pointed out that apprentice licenses cannot be reissued without completion of required refresher courses. However, given that the board is granting an extension, it is hoped that candidates will use this opportunity seriously to pass the exam.			
	J. Blas confirmed that the plan is to approve a three-month extension for the re- examination and the apprentice permit. He noted that this extension would be the final one, and the apprentices should be informed that their apprenticeship will no longer be valid after this period. A. Taitano agreed and added that the extension will be granted on a case-by-case basis. She emphasized that apprentices who have had their licenses for over two years, received multiple extensions, and attempted the re-examination several times should be given this three-month period. She questioned whether it is appropriate for a cosmetologist to supervise a barber apprentice, given that cosmetologists are not permitted to perform certain barbering services, such as straight razor shaving. A. Taitano noted that while the barber apprentices could perform haircuts under a cosmetologist, they would be unable to perform other barbering services that distinguish a barber from a cosmetologist.
